### **Business Taxes**

- 1. Value-added tax refund for export-oriented manufacturing sector
  - Public-Private Consultative meeting on the draft VAT law
  - Commenting on the draft VAT Implementation Instruction
- 2. Excise Tax on Internet service charges
  - Public-Private Consultative meeting on the draft Excise Tax law: agreed to reduce the internet excise tax from 10% to 5%.

### Trade facilitation and logistics (1)

- 1. Lengthy and time-consuming process of importing and exporting goods and materials for production, exempted from import duty under Investment Promotion Law.
  - MPI sent a notification letter to the MoF to cancel the Instruction no 3578/MoF, dated 19 December 2012, issued by Minister of Finance on the implementation of Customs-Tax Policy in accordance with Investment Promotion Policy.
  - LNCCI and MPI organized a public-private consultative meeting for acquiring comments from the private sector on the draft implementation instruction on Investment Promotion for Master-list.
  - Customs department has completed installation of and started to implement the electronic monitoring system for the control and clearance of goods imported under Master List at every major international customs border as well as customs management outlets across the country.
- 2. Lack of enforcement of regulations on local traditional customs check points.
- MoF will work with local authorities to reassess the effectiveness of the implementation of the Announcement No. 4115/MoF, and will make amendments to this announcement so that it will comply with actual practices. (No further update )

#### Trade facilitation and logistics (2)

- 3. High cost of domestic and international transport.
  - Customs Dept issued a notification on fees collected on transit vehicles, and vehicles entering and exiting Lao PDR, dated 27 September 2018
  - However the notification is still unclear on some cases, thus has not been implemented
- 4. Restrictions of lists of goods and borders for goods in transit.
  - Aagreement between the clients of logistics firms and their trading partners is no longer required
  - Restriction on transit goods are still imposed

### Other Priority Issues-updates

Procedures for business registration and business operating licenses

- MoIC Completed and implemented the Instruction on starting a business (individual or legal entity) No. 0537/MOIC, dated 4 May 2018,
- Issued a notice on business registration (individual or legal entity) No. 1120/MOIC.ERM, dated 15 May 2018, as well as organized a consultation meeting with line agencies at the central level.
- Coordinated with the Ministry of Finance on the new business registration system by which the investors will be able to receive tax identification
- \*Access to information on government procurement plans
  - Law on government procurement is enforced yet implementation instruction has not been released.
